## TERMS OF AGREEMENT:

- Rooster Andy's will provide ½ chicken, potato salad, baked beans and dinner roll per each order. With each dinner ordered, Rooster Andy will also provide all serving products, tent, sign and heated bags if desired for delivery.
- A non-refundable deposit of \$100.00 is required at time of booking. This deposit is applicable to the final bill.
- Customers selling tickets are responsible for printing and are encouraged to sell at least 300 dinners.
- Customer will include Rooster Andy's name on all tickets and advertising.
- Customers are responsible to pay for a minimum of 300 chicken dinners.
- Customer will provide a minimum of four people to serve food and collect tickets and money on the day of event.
- On the day of the event a representative of group will be there ½ hour before scheduled serving time.
- At least ten days prior to your event, count tickets sold and contact Rooster Andy's to place initial order. Update on counts can continue up till day of event. Minimum order is 300 chicken dinners.
- On site cooking availability is based on location, minimum order, and scheduled date.
- The customer may keep extra food, provided they supply their own containers. Customer agrees to hold Rooster Andy's harmless for the quality and condition of any extra food after it is in the customer's possession.
- **BILL IS DUE 7 DAYS AFTER DATE OF EVENT. A 5% LATE FEE WILL BE APPLIES TO ALL BILLS NOT PAID WITHIN THE 7 DAYS. Make checks payable to Rooster Andy's.**
