Terms of Agreement

- ✔ Rooster Andy's will provide 1/2 chicken, potato salad, baked beans, and dinner roll per each order. With each dinner ordered, Rooster Andy will also provide trays, forks, napkins, and serving tent.
- ✔ CUSTOMER WILL MAKE A MINIMUM PROFIT OF \$300.00 contingent upon the successful completion of the terms listed within this agreement.
- ✔ A non-refundable deposit (above) is required at time of booking. This deposit is applicable to the final bill.
- ✔ Customer will supply and pre-sell a minimum of 300 chicken dinner tickets, and are encouraged to sell beyond 300 tickets to maximize fund raising potential.
- ✔ Customer will include Rooster Andy's name on all tickets and advertising.
- ✔ **Event must be paid in full on or before the day of the event.** Make check payable to Rooster Andy's. A late payment fee of \$50.00 will apply unless prior arrangements have been made with Rooster Andy's. Payment must be in cash or a single check unless prior arrangements have been made.
- ✔ **At least five days prior to your event, count tickets sold and contact Rooster Andy's to place final order (300 minimum).**
- ✔ Customer will provide a minimum of four people to serve food and collect tickets and money on the day of the event.
- ✔ The customer may keep any extra food, provided they supply their own containers. Customer agrees to hold Rooster Andy's harmless for the quality and condition of any extra food after it is in the customers possession.
- ✔ A cash deposit will be required for any equipment borrowed by the customer. All borrowed equipment must be returned within 24 hours of the end of the event in same condition for return of deposit.
